

### CANCELLATIONS:

Full refund if cancellation is received up to 30 days prior to departure. Later cancellations forfeit \$50.00 per person plus a pro-rata share of room occupancy charges plus any additional fees levied against the group. Cancellations within 14 days of departure are non-refundable. Cancellations must be made directly to our office, not your group organizer, in order to be eligible for any refund. ### BAGGAGE:

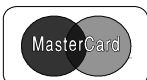
