

GENERAL INFORMATION AND CONDITIONS

CANCELLATIONS:

Full refund if cancellation is received up to 30 days prior to departure. Later cancellations forfeit \$50.00 per person plus a pro-rata share of room occupancy charges plus any additional fees levied against the group. Cancellations within 14 days of departure are non-refundable. Cancellations must be made directly to our office, not your group organizer, in order to eligible for any refund. TRIP CANCELLATION INSURANCE IS RECOMMENDED. *Please call for information*.

BAGGAGE:

Although every effort is made to handle luggage carefully, tour operator acts only as agent for passenger and cannot assume liability or accept claims for lost or damaged luggage (including privately owned or rental ski equipment) due to breakage, theft, hotel or carrier handling, fair wear and tear, etc.

ALCOHOLIC BEVERAGE REQUIREMENTS

Tour members must be of the minimum drinking age allowed by the State in which the destination is located to participate in the functions or tour inclusions which contain alcoholic beverages. Each liquor outlet requires two types of identification (one must be a photo ID) and reserves the right not to serve alcoholic beverages to any individual who does not meet their standard of service even though they may have paid for the alcoholic beverage as part of their tour.
